### **Harris Bilingual Immersion School**

#### **Title I Parent Involvement Policy**

In accord with federal law, the school and the parents of students participating in the Title I program have jointly developed the following parent involvement policy that shall be a part of the school's Title I plan. The term, "parent" as used in this policy, is defined as a parent or guardian of a child receiving Title I services.

## **Program Involvement**

The Title I staff will invite all parents of students receiving Title I services to an informational meeting in September or October of each school year. The parents shall receive a written notice of the meeting. As the meeting, parents will receive information about the Title I program, including the right of parents to be involved. The school shall offer a flexible number of meetings, such as meetings in the morning or evening. The school may choose to:

- Provide additional reminders of the meeting by phone, email, Title I or school newsletters ad calendars, posting on doors, or bulletin boards.
- Hold the meeting in conjunction with another event such as back to school night, a student performance or art show.
- Provide a video with the information for parents who are unable to attend the meeting.
- Provide childcare
- Provide food
- Provide translation of materials
- Provide for translation of the meeting either through video or simultaneously
- Enlist former Title I students and parents to be a part of the presentation, to answer questions, address concerns, offer suggestions, or share how the program made a difference int heir lives
- Home visits

Harris Bilingual Immersion Elementary School will involve parents in the planning, review, and improvement of the *Harris Bilingual* Title I Parent Involvement Policy. Parents will be involved in an organizing, ongoing, and timely way including the opportunity to provide input through a fall Title I Parent Survey and a spring Title I District Parent Involvement Policy Evaluation which will be sent home to each parent in their child's Title I book bag or *Thursday folder*. In addition, parents may be involved in the planning, review and improvement if the Title I program at *Harris Bilingual Elementary* School by

- Providing suggestions during parent-teacher conferences
- Serving on the Title I community-Parent Advisory Council (C-PAC)
- Serving on the *Harris Bilingual School Improvement Team*
- Filling out an evaluation form or speaking with the Title I teacher at a parent family math or literacy night

- Requesting a meeting or phone conference with the Title I teacher
- Making a comment on the student's nightly or weekly book note
- Phoning or emailing the title I teacher with a suggestion
- Serving as a mentor to new Title I parents

Parents of children served by the Title I program will be provided with timely information about the program, the curriculum used by the school, the academic assessments used to measure students progress, the proficiency level students are expected to meet and the services of the State Parent Information and Resource Center (PIRC). Parents may request opportunities for regular meetings to formulate suggestions and to participate as appropriate in decisions relating to the education of their children. Information may be provided in the following ways:

- During the October parent information meeting
- During parent-teacher conferences
- During a conference with a Title I teacher
- During a presentation such as back to school night

## **Shared Responsibilities for High Student Academic Achievement**

As a part of this policy, a school-parent compact has been jointly developed with parents for all children *served by the Title I program*. The compact outlines how parents, the school staff, and studnets will share responsibility for improved student academic achievement and develop a partnership to help children achieve the State's high standards.

#### **Building Capacity for Involvement**

Parents shall receive information on how to monitor their child's progress and how to work with educators to improve achievement of their children. *Harris Bilingual Immersion School* shall provide materials and training to help parents to work with their children to improve their children's achievement. These may be provided by:

- Title I parent workshops following input from parents on the fall parent survey
- School or district workshops
- Information in school newsletters
- Take home activity packets
- Programs on the PSD television channel
- Enlisting parents to help plan and/or present workshops
- Videotape, DVDs, books or cassettes available to parents to check out
- Other (please describe)

Teachers, student services personnel, principals, and other staff shall be educated in the area of parent involvement including the value and usefulness of contribution of parents, how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and school. This may occur:
